### 3 巴西 Brazil ANATEL

日前 Brazil ANATEL 公佈所有 RF 產品需強制 EMC 測試，原預計在近日會確認正式執行日期，2018/06/28 公告因為測試技術上的困難度將再次延期至少兩個月以上

ANATEL in Brazil published regulations in the recent past confirming that RF devices will require EMC Radiated Emissions and Radiated Immunity tests. However, because of difficulties in defining the best test methodology for RF devices with multiple technologies and frequencies, the Regulator decided one more time to postpone the date when these tests will be mandatory.

On June 28, 2018, Act 4735 was published confirming that the postponement period is up to 2 months.



### 4 阿爾及利亞 Algeria RF

Algeria 針對 SRD 產品，發證單位將由 ARPT 變更為 ANF，不影響現已發證產品。

An updated Telecom Law was released in the OFFICIAL JOURNAL OF THE ALGERIAN REPUBLIC N° 27 and has transferred the regulatory authority power from ARPT to ANF for the provision of type approvals for SRD products. All current ARPT type approval certificates will remain valid until expiration.

### 5 哥斯大黎加 Costa Rica SUTEL

Costa Rica 發證單位 SUTEL 日前發佈新法規 N°87 Resolution RCS-154-2018，取代舊法規 Resolution RCS-431-2010，內容增加部份免授權/免執照頻段，及針對這些頻段取得認證的要求。

SUTEL in Costa Rica has released N°87 of their official journal La Gaceta, including Resolution RCS-154-2018 that replaces Resolution RCS-431-2010 regarding the Type Approval guidelines for products operating in the unlicensed frequency bands in Costa Rica. Under RCS-154-2018, the “Bandas Libres” or Unlicensed Bands have been expanded, and there are new requirements to obtain Type Approval in these bands.
